- 3. Candidates will be contacted by the Nominations Committee if it is determined that an inperson interview is necessary. If required the interview will occur after March 28^{th} , 2024, but not later than Tuesday, April 16^{th} , 11:59 pm.
- 4. Candidates failing to submit a complete declaration of candidacy by April 9th, 2024 or if required by the Nominations Committee fails to participate in an in-person interview on or before Tuesday April 16th, 2024 will not be considered for endorsement.
- 5. Nominations for the endorsement will not be considered from the floor.
